3. Treasurer's Report : Greg Papp

Total Assets: \$10,761.40

October and November's income totalled \$960 from individual memberships primarily received at social functions. With the combination of website fees, special events and meeting expenses, our October and November's expenses total \$1679.49. This leaves us with an 11 month deficit of \$347.75. It is clear to me that in order to at least balance our income and expenses year-over-year, I must make a more concerted effort to collect the Corporation membership fees.

So far we have received payment from 33 Mill St. and 39 Parliament St. I sent reminders to all other property managers yet have not received replies nor cheques.

Discussion: regarding payment cheques sent by condo corporations that have not been received by the Treasurer. The mailbox 101 at 39 Parliament for GWNA is shared with that building's property management which may be contributing to cheques for GWNA going astray. Greg to ask the Property Manager at 39 Parliament if there's a box available that could be dedicated to GWNA.

4. Membership Report

- To date we have 61 memberships for 2024 13 of those are new
- At the 39 Parliament Street renewal event on November 5,2023, 30 memberships were signed up, At the Neighbours Night Out 27 memberships

- I had a few people who had signed up in early/mid October complain to me about having to sign up/pay again for their renewals for 2024. I rolled over their memberships to 2024.
- The new system with electronic cards seems to be working very well; I would like to find a better way of how to streamline the process of signing up members in person when we have line ups
- We need to discuss the cut-off date to take non renewed members off the mailing list. Perhaps do a write up in the GWNA newsletter to remind people to renew or risk not receiving further newsletters,
- Having an event early in the year for 2024 may have the benefit of renewing/signing up more memberships for the current year
- I would like to find volunteers for each of the GWNA buildings to undertake a membership drive early in the New Year
- It would be ideal if we could do a membership drive among the businesses located in the Distillery.

Discussion: It was agreed that the cut-off date for renewals would be March 1st. Catherine Schryer agreed to assist with a membership drive at 80 Mill St. Mark Wagner agreed to develop a QR code to assist with payments.

• On November 7 the website subscription with Squarespace was renewed for another year.

d) Greening Committee: Diana Belshaw

The Greening Group has made a good start towards the naturalisation of the Mill St. Boulevard. Many thanks to Mark Wagner who has kept on top of the equipment needs as well as to almost 14 members who assisted.

To date, we have:

1. Completed the first stage of preparation of the boulevard over two weekends by removing as

many seeding weeds as possible and cutting down the first rank of unwanted bushes and suckers. We also picked up as much garbage as we could.

2. Connected with City Waste Management in order to remove the green waste. They have been splendid!

3. Received formal permission to garden the site from FCA Canada (Stellantis) who hold the lease from Infrastructure Ontario

4. Held a very successful 'seeding bee' during which we removed thousands of tiny seeds from the seed heads gathered from the 39 Parliament St. native garden. They are sitting in jars waiting for spring.

e) Halloween event
